The Ga Mountain Food Bank is located in Flowery Branch and provides food to our local area through group homes, children's programs, food pantries, etc. In Hall County they work with the Hall County Boys & Girls Club to supply healthy snacks and drinks for the after school program. In a joint program with Feeding Our Future program and the Junior League of Hall County they work with the school system counselors identifying children and families in need. Each month food boxes are distributed on Saturdays to these families.

The Ga Mountain Food Bank is also in the process of organizing a Summer Feeding Program. During the school year these children receive breakfast and lunch at school but in the Summer it is not available to them. They are working to meet this crucial need. **You have played a big part to help!**
